Shootings in the neighborhood continued to be a point of concern and discussion, around how can the KNA be a contributor towards a solution?

There needs to be an emphasis on Portland's youth and finding alternatives to being in gangs.

The Highland Christian Center Mentorship Program and the Blazer's Boys and Girls Club were two examples of organizations trying to work with youth and provide alternatives. Key aspects needed are teaching pertinent life skills, such as how to establish credit and build life and work experience via mentorship programs that work directly with youth and which not only seek to give them skills, but also just a friendly sympathetic face to help with any of life's challenges.

From a law enforcement perspective, there was discussion about the Gun Violence Response task force currently being organized in the PPB, and how it was meeting with resistance, due to police officers perceived reluctance to have a civilian oversight committee reviewing their work. Hardly any police officers had volunteered to take part. So even though the organization exists on paper, effectively it does not exist presently and that there doesn't seem to be current police effort. Gangs are well-organized and wellfunded; they are in essence organized crime, which makes them difficult to combat. It was mentioned the FBI had a task force in Portland to help with gun violence, but there was no information of the scope of their efforts, nor if they had been able to make any impact to date.

Darcell asked about the schedule

Paxton answered: pickups often as you want; suggested 2x a month First times out, there tends to be lots of trash, but gets better over time, unless the cleanup is on a major route. MLK, for example, never seems to get better no matter how much effort is put into it

Use events like this to get people involved in community interest Entire families can participate

Libby moved to approve; John K seconded; Vote to approve of flyer motion passed unanimously Libby proposed KNA do adopt a block once per month; Eryca seconded; Unanimous

John R had to leave; Libby took over running meeting

Perhaps Solar Oregon could bring in two or three experts

Investigate: getting tent at local Farmer's Market and for what the cost would be for a tent, printing materials

Action item: Martina and Libby

Noise issue at King Elementary Park

Neighbor - noise only getting worse

Recommendation: keep filing complaints to establish paper trail, even if the City continues to do nothing

Update: Talked to head of Parks Department. Additional rangers still only at proposal stage for new budget. Nothing being done currently or likely to be done from Parks in near future.

Responder was supposed to have been given contact info for the head of the Park Rangers (permission was already given to give responder this information.) At last meeting, this had not yet been done.

Action: get head of Park Rangers contact info to affected neighbor(s) for direction dialogue. Action item: Eryca

Open Forum

Darcell Dance: Inquired about construction on 9th

Crosswalk at 9th and Webster Concerned that PBOT is taking stop signs away Comment: People don't stop at stop signs anyway, so putting an apparatus on road might work better.

Libby: All these changes on 9th took parking spots away, people won't be able to park in front of house

Darcell Dance: City/PBOT unlikely to do anything to address situation

Paxton: roadways built for cars City of Portland putting greenway on 9th; this is a step in right direction in his opinion. Anti-traffic blocks an idea as speedbumps on 7th not working
